

ALBERTA BEEF PLEBISCITE

At the request of the Alberta Beef Producers, the Alberta Agricultural Products Marketing Council (Marketing Council) conducted a plebiscite from October 19 to November 27, 2018, on the matter of the ABP's service charge model refundability.

The plebiscite asked producers to vote on whether the Alberta Beef Producers should operate on a non-refundable service charge model or on a refundable service charge model.

The official results of the ballot count are as follows:

Number of votes cast = 1874 51.3% votes for refundable 48.5% votes for non-refundable 0.2% of votes were spoiled

The plebiscite regulation allow for provisions for contesting the plebiscite. No contests were raised to the Returning Officer by the date outlined in the regulation (December 11, 2018).

BOVINE TB IN BC

A suspected case of Bovine tuberculosis (bTB) was detected during a routine post-mortem examination of a mature beef cow at a processing facility in Alberta and confirmed through testing by the Canadian Food Inspection Agency (CFIA). The carcass was condemned and did not enter the food chain. The animal was traced back to a farm in British Columbia. The CFIA, in conjunction with the Province of B.C. launched an immediate epidemiological investigation at the farm of origin and issued movement control restrictions on the impacted animals. The investigation is ongoing. No trade impact is anticipated as a result of this finding. CFIA does not believe the this case is related to the case in Alberta discovered in 2016. The strain of TB will be determined by a tissue culture which takes 8-12 weeks.

The CFIA is working with the producers and provinces to take immediate action to control the disease and maintain Canada's bTB-free status. Currently seven premises in Alberta, BC and Saskatchewan (including the index premise) are under movement controls as a result of the trace-out investigation.

PUBLIC CONSULTATION ON BIGHORN COUNTRY

The government of Alberta has released a proposal for multiple designations in Bighorn Country which include a new Wildland Provincial Park, as well as new, expanded or amended Provincial Parks, Public Recreation Areas and Public Land Use Zones (PLUZ). The government is stating that, for many stakeholders, the proposal means little or no significant change to currently allowable activities which includes existing grazing dispositions on Crown land. It is appreciated that the Government recognizes the importance of grazing and timber harvest in the overall health of the working landscape, but there is very little trust in the government by those who operate within the boundaries of the proposed Bighorn Country to keep this promise. This lack of trust is further fueled by the fact that the government circumvented it's own procedure within the Land Use Framework. This proposal was developed ahead of the North Saskatchewan Regional Plan and seemingly against some of the the recommendations that came from the NSRP Regional Advisory Committee.

It also appears that new or expanded grazing dispositions would not be considered as a tool for land management within the Bighorn park system even though science has proven the importance of a grazing animal in the health of the grassland ecosystem, and this includes grassland areas within forestry.

WSGA believes that it is not necessary to create new conservation directives (parks) on Crown land to sustain or conserve ecosystem function. Biodiversity and ecosystem function are sustained by appropriate management of lands and are unrelated to conservation designation.
