### **2019 AGM Resolutions**

#### **RESOLUTION #1**

WHEREAS the Bighorn Country Proposal goes around the land use framework process and WHEREAS given the timing and the apparent or perceived lack of respect for appropriate planning, co-operation and communication to the citizens of Alberta

THEREFORE BE IT RESOLVED that we encourage the Alberta Government to respect the North Saskatchewan Regional Planning process in regards to the Bighorn Country Proposal

### **RESOLUTION #2**

WHEREAS the United Conservative Party of Alberta has continued to promise to repeal Bill 6 if they are elected and

WHEREAS the costs to the producer of fully implementing Bill 6 are significant in both money and time, especially for smaller farms and ranches

THEREFORE BE IT RESOLVED, if United Conservative Party of Alberta is elected, the Western Stock Growers' Association lobby the Alberta Government to repeal Bill 6 as soon as possible

#### **RESOLUTION #3**

WHEREAS the Endangered Species Conservation Committee recommended listing wood and plains bison as threatened and

WHEREAS the Government of Canada Recovery Strategy for Wood Bison identifies tuberculosis and brucellosis as threats and recommends to "contain and prevent the spread of bovine tuberculosis and brucellosis from wood bison local populations with diseases to disease-free local populations cattle and ranched bison, and evaluate current disease management options"

THEREFORE BE IT RESOLVED that Western Stock Growers' Association holds liable the Government of Canada for any disease escape from the bison population and encourage the Government of Canada to move forward immediately with this strategy, and offer to collaborate in the design and delivery of the same.

### **RESOLUTION #4**

WHEREAS Alberta has over fifty years of successful participation in the four-way provincial partnership that established and funded the Western College of Veterinary Medicine; and

WHEREAS over those years, Albertan has consistently registered more veterinarians than it has funded; and

WHEREAS WCVM and UCVM have different teaching models particularly for clinical experience; and WHEREAS Alberta's withdrawal from the WCVM funding partnership will challenge the viability of the entire WCVM program – affecting not just Alberta students but Western Canadian students,

THEREFORE be it resolved that WSGA lobby the Provincial government and Official opposition to reestablish funding for at least ten seats annually for Alberta undergraduate students at WCVM.

### **UPDATE: Bovine TB Investigation in BC**

The Canadian Food Inspection Agency's investigation now has one herd each in B.C. and Saskatchewan and four herds in Alberta under movement controls, along with the infected herd in B.C. Twenty-seven other herds put under movement controls since the start of the investigation in November, including 15 herds in Alberta and 12 in B.C., have since been released.

The investigation started after lab tests on Nov. 9 confirmed bovine TB in an animal traced to a farm in B.C.'s southern Interior. Since then, three other animals on the farm have tested positive.

Culture testing of tissue samples collected from the four infected animals has been completed, showing all four were infected with the same strain of bovine TB. CFIA noted the strain of bovine TB in this case is "distinct from any cases" previously detected in Canadian wildlife or domestic livestock." That includes past cases of bovine TB in Alberta or British Columbia or anywhere else in Canada. The U.S. Department of Agriculture has also confirmed the strain in this case "has not been previously identified by its laboratory service."

Tracing movements of animals into and out of the infected herd during the past five years is still ongoing, CFIA said. "These efforts are in place to identify and eliminate the source of the disease and to prevent any potential spread of the disease."

No source of disease was found in the 2016 TB case in Alberta after CFIA trace in and trace out investigation.
