Touching on the highlights of the past year, our activities included, but were not limited to:

- Representing cow/calf producers at the Real Property Rights Committee in person public meetings
- Wildlife Damage Invoicing seeking compensation for time, material, and property loss incurred from wildlife.
- Grasslands Capital X Project, which has recently evolved into another pilot project called Carbon Plus Exchange seeking a free market approach to marketing carbon and other environmental services.
- Summer Meeting and AGM held at Bill and Jeanne Hansen's near Valleyview Alberta
 - AGM Resolutions:
 - Changing the number of WSGA membership zones from 11 to 4.
 - Lobby the Provincial Government to implement a management solution for feral horses in Alberta.
- Working jointly with AGLA and ABP towards resolving the access and liability issues regarding
 undeveloped road allowances. Together our three organizations met with representatives from RMA. We
 also have begun meeting with local Ag Service Boards, and Municipalities, seeking resolutions for
 clarification on liabilities and responsibilities surrounding undeveloped road allowances.
- Vocalizing our concerns and opinions at the Grazing Timber Integration Consultation and we are looking forward to continued involvement in that.
- Participated in preliminary meetings with ACFA and ABP regarding Truck Driver Insurance Issues.
- Collaborating with our friends at AGLA explaining our concerns and priorities, identifying common issues we have, and where we can work together.

Recently a few of us from WSGA and AGLA travelled to the Alberta Legislature and met with Premier Danielle Smith, Minister of Forestry Parks and Tourism Todd Loewen, Minister of Agriculture and Irrigation Nate Horner, and MLA from Cypress – Medicine Hat, Drew Barnes. The reception was warm, the discussion was excellent. We just now need to stay engaged so the seeds we sowed will bear fruit.

While we were at the Legislature, we were invited to watch Question Period. As I sat watching, I thought of all the important decisions made and debated by great men and women, in great rooms and halls just like that one. I thought of how those decisions directly affected taxpayers, entrepreneurs, farmers, and ranchers just like you and myself. Valuing wildlife damage -WSGA's wildlife invoice project

Many ranchers suffer losses at the hands of populations of ungulates or migratory birds. Others suffer from wolf or cougar or grizzly bear predation. These are both a result of the Crown failing to manage their wildlife property in a balanced manner.

These are not new issues. WSGA has discussed the Crown's gross mismanagement of wildlife with every Environment Minister since the inception of the department. In addition, we have discussed potential solutions with those Ministers and their bureaucracy. Surely if it is in the public interest to have the current levels of wildlife populations then it is the Crown's responsibility as the agent of the public to compensate for the damages those populations cause to private property.

Unfortunately, compensation programs are limited, restrictive, and largely ineffective. For example, predator losses must be found while still sufficiently intact to determine predation as the cause of death; perennial crops such as pasture are not eligible for compensation even though wildlife cause production losses, and stored feed losses are ineligible unless the feed is located in a fenced enclosure. This severely limits certain management options that may be more cost effective. Furthermore, scientific studies have revealed the bio-security concerns resulting from the co-mingling of domestic livestock and wildlife.

WSGA has developed an online wildlife damage invoice to record the financial burden that wildlife owned by the Crown incur upon private citizens. The invoice, available to WSGA members only, allows ranchers to record damage, repairs, and upload photos. Invoices are submitted to the WSGA office where they will be sent in batches to the Ministry of Environment and Protected Areas and the Ministry of Agriculture and Irrigation.

On-Farm Climate Action Funding (OFCAF) Update

The On-Farm Climate Action Fund (OFCAF) is a cost-share funding program that supports farmers in adopting best management practices (BMPs) that reduce greenhouse gas (GHGs) emissions and store carbon, specifically for in-field nitrogen management, expanding cover cropping, and implementing rotational grazing practices.

This program helps producers adopt different practices by offsetting 85% of the cost. Alberta farmers and ranchers can apply for up to \$75,000 in funding to implement practices related to nitrogen management, rotational grazing, and cover cropping. The money can be used to cover multiple projects to a combined maximum of \$75,000.

There are two application windows in this program. The first window closed on November 7, 2022. The next round of OFCAF funding will open on February 13, 2023. For guidance on how to prepare and submit your application visit rdar.ca/ofcaf.

Carbon + Exchange Pilot making progress

The Carbon + Exchange is the next generation of EGS market pilot project undertaken by WSGA; following our Grassland Capital X pilot. We have been talking about and supporting initiatives in and around a market for ecosystem services for decades. Undertaking these pilot projects has been a big commitment by WSGA but we have seen progress, which is heartening. The latest pilot, the Carbon + Exchange, is funded by RDAR and has presented it's fair share of barriers that we have needed to address. But that is to be expected when you are forging new roads.

For the pilot, we have gathered eight WSGA member volunteers with a total of approximately 40,000 hectares of grassland to enter a Carbon Plus market. The pilot looks at testing the grassland index metrics and processes outlined in our first pilot and also at adding value to an existing carbon exchange process. We have been working on building relationships between buyers and sellers in an exchange and are very close to initiating contracts. In this pilot we have also looked at whether a rangeland health

assessment can be used to ground-truth and verify the biological indicators in the Grassland Capital X index.

The procedure we are testing involves engaging an aggregator that works with ranchers who are capturing carbon and delivers the carbon credits to buyers the aggregator has contracts with. The land is evaluated to determine potential carbon gains and if thresholds for profit are met, they enter into an agreement with the rancher. From there, a soil sampling plan is developed and baseline soil data is collected. Ranchers are paid for carbon gains (measured every five years) based on the market value of carbon. The land entered into the contract must remain as grasslands for a minimum of 15 years, with a rolling contract option.

The pilot runs until March 31, 2023 after which time we can fully present our findings and progress in this exciting field. Stay tuned...


New WSGA Membership Zones
